# Introduction

Dear Friends,

This is the sixteenth year that we have held Forum 2000. However, this year is the first time that we are coming together without President Václav Havel: our steadfast leader in our quest to deepen what he referred to as our spiritual experience.

Throughout the past fifteen years, he taught us something very important. That is, in order to solve our world's problems at their most basic level, it is not enough to simply implement new mechanisms, new regulations or new institutions. Each one of us must first turn our gaze again to our own fundamental spirit. Our own moral base. Our own conscience. Then, after deep reflection, we must make the necessary changes to these most central parts of ourselves. Only then should we begin to search for external solutions.

Over the past decade and a half, President Havel was our teacher. He was our exemplar. He guided us as we took up such vital issues as our sense of responsibility, faith and trust. He pushed us to delve into the complex issues surrounding spiritual, moral and cultural values.

It is meaningful that he did this here, in Prague. Prague lies at the center of Europe. It is a crossroads of thought and ideas. This city has experienced, more than many, the turbulent extremes of our age. Prague has witnessed humankind's worst lies and our deepest truths. It has seen our gravest threats and has come to embody some of our brightest hopes. It is the most suitable place imaginable for us to come together every year to further pursue these thoughts and ideas with the rigor that President Havel asked of us. And when we send our new ideas out into the world from Prague, they are not only filled with hope. They inspire hope.

The legacy of President Havel – his moral and intellectual leadership – is alive here today, watching over us and inspiring us all to personally take responsibility as we walk day by day toward the world we want to live in. Let us strive to live up to his example this year again and make our debate even more active, thought-provoking and world-changing than ever.

"When [Václav Havel] established Forum 2000, it was on the principle that it would be good if informed and concerned people, from different continents, different cultures, from different religious circles, but also from different disciplines of human knowledge could come together to talk calmly with each other. This, it seems to me, is the most appropriate way to promote democracy in non-democratic countries and to support respect for human rights and religious, culture and ethnic tolerance in young democracies. I have assured the Forum 2000 Foundation that I shall be very happy to do whatever I can to contribute to its work and keep alive the spirit of freedom that Václav Havel made such efforts to promote."

# Václav Havel's Legacy

#### Václav Havel: The Powerful Powerless

In 1990, Václav Havel was the first to invite His Holiness the Dalai Lama on an official state visit. In 1991, he successfully nominated Aung San Suu Kyi for the Nobel Peace Prize, bringing the plight of Burmese people to the center of world attention. In 2010, Václav Havel, in the framework of Forum 2000's Shared Concern Initiative, initiated the successful campaign to award the Nobel Peace Prize to Liu Xiaobo. In the meantime, he established the Forum 2000 conferences to create a framework for civilized dialogue about crucial and difficult issues facing civilization. Václav Havel was a hero to his nation, but his reach was global. Despite his passing last year, his work is not over.

- What are the key elements of Václav Havel's human rights and democratic legacy?
- What is the future of this legacy?
- Where can and should Forum 2000 take it? What is the role for the organization and the annual conference?

#### Václav Havel as a Media Practitioner

Václav Havel interacted with the media most of his life. He was a consumer of media, as well as a protagonist and object of media interest. Before November 1989, in one of his interviews with Radio Free Europe, he stressed the importance of media interest in him and his beliefs and the resulting support of international public opinion for dissidents in Czechoslovakia. During his presidential tenure, he bathed in media sympathies but also suffered from occasional media invasions of his privacy. After leaving office he had yet another perspective.

- How did Václav Havel view the role of the media in a democratic society?
- How did he interact with the press during various periods of his life?
- Was he satisfied with the way media in the democratic Czechoslovakia and Czech Republic developed?

## Václav Havel's Civil Society

Václav Havel believed a strong and thriving civil society to be the key element of a functioning democracy. Throughout his life and political career, he was involved with a number of civil society groups, movements and initiatives. After his death in December 2011, as a part of his legacy, several NGOs that he either personally created or was closely involved with, remained. Among them, Forum 2000 Foundation, Vize 97 Foundation, Václav Havel Library, Charter 77 Foundation, and People in Need.

# **Changing Role of the Media**

Media, especially in electronic form, is changing our lifestyle at an unprecedented rate. Internet and related phenomena like Facebook and Twitter have given the term globalization new meaning. At the same time, technical advances and economic pressures threaten the very existence of such pillars of Western Civilization as books and newspapers. Some observers see great promise in the ever-increasing availability of news, data and intellectual content everywhere, anytime. Others fear an onslaught of reckless media disregarding any right to privacy.

- What is the role of media in responsible societies?
   What is new about this?
- Is more government regulation of media necessary?
- If media so easily transcends borders, is regulation even possible?

# Electronic Activism and Democratization of the Public Sphere

*In cooperation with the Association for International Affairs* 

Protests demanding more citizen involvement in politics and responses to humanitarian crises have highlighted the power of open and innovative electronic communication. New crowdsourced media are free information canals, open mobilization platforms, broad agenda-making spaces and watchdogs. As such, they multiply possibilities of citizen participation in public affairs. They were and still are particularly crucial in countries with limited civic freedoms and those on a transition path. Yet those more or less consolidated democracies in Eastern Europe also see themselves confronted with the challenge of enhancing citizen participation in decision making and of limiting the effects of corruption.

- What is the role of new media in already democratic states?
- Can social networks be used in government as well as they are used in entertainment?
- Does technology open a path to more direct democracy?

#### The Future of the Media in Asia

Asia is not only the most populous continent, but also an emerging economic center of gravity in the world. This vast territory is also characterized by extreme diversity in both peoples and politics. What happens to burgeoning democratic aspirations in this part of the world has serious implications for the rest of the world. Media has a role to play in these events.

- How have the media and democracy influenced each other in Asia?
- What are the persisting constraints in further democratization of Asia?
- Has the changing face of the media affected the Asian democratic experience or different Asian experiences?

### **Media Choice, Polarization and Democracy**

In cooperation with Respekt

With increased media choices the so-called "knowledge gap" increases as the politically engaged choose political information and others increasingly avoid it. At the same time increased choices for consumers allow them to choose media that reinforces their existing beliefs. Both trends have the potential to polarize the public and have profound impacts on democracy. Running contrary, however, is that increased choices guarantee there is no monopoly on information.

- What are the implications of these two opposing tensions on an informed electorate and democratic participation?
- Are there such things as facts? Are common historical narratives a thing of the past?
- Is new media both an asset and impediment to democracy?

#### The Al Jazeera Phenomenon

Established in 1996, Al Jazeera, a broadcaster owned by the state of Qatar, has gradually become one of the most influential media organizations in the world. It has been criticized for supporting terrorism and anti-Americanism, but also credited with having a major positive influence during the Arab Spring. It is one of the key sources of information on the Middle East, but also on Africa and other regions. Al Jazeera Balkans, for example, has been called "an island of media professionalism in the region."

- How important is Al Jazeera's political and social influence?
- Is it a force for democratization in the Middle East?
- How is it different from more traditional Western media outlets, like the BBC or CNN?

# Diplomacy in the Age of New Media

In cooperation with the Embassy of France to the Czech Republic

As the role of Internet, social networks and other forms of new media grow, diplomacy aims to follow. Professional diplomats and ministries have Facebook and Twitter accounts. This suggests that changing media landscapes and ways of communicating with national publics offer both challenges and opportunities to the way statecraft is made and done.

- How can social networks and new media integrate with traditional diplomacy?
- How can diplomacy through the use of new media contribute to supporting democracy and human rights?
- How do activists in unfree countries view the role of traditional western diplomacy in their work? How can new media and social networks help them?

### The Role of Social Media in Today's Belarus

In cooperation with People in Need

After the largely successful suppression of opposition following the 2010 Presidential election, Belarus again seems to be quite firmly under the control of the Lukashenka regime. But is it really? The economy is in tatters and despite the repression, public happenings and displays of discontent continue. Social media is playing an increasingly central role in bypassing traditional channels of communication monitored by the government.

- How do activists coordinate and reach out to the public in preparation of happenings like "silent protests"?
- To what extent does social media substitute for debate that cannot take place in public space?
- Does the regime counter with its own online activities (paid bloggers, etc.)?

### **Media as a Religion**

Media is in a certain sense a religion in today's world, playing many roles that were traditionally played by religion. Media outlets are interpreters of words, the arbiters of true meaning and importance of events, the forum through which big symbols and stories are conveyed and influence the thinking and way of life of the masses. The media creates a certain form of common identity, which works as a unifying element of society.

- To what extent are the media really taking over social roles previously played by other institutions?
- In what ways is the role and place of religion in our society changing?
- Are such trends global, or merely present in the more-secular West?

# Media (R)evolution: Media Changes in Central Europe?

In cooperation with Aspen Institute Prague

The medium of print is attracting radically less attention, whereas mobile technology may soon become the media access point for a majority of consumers. All stakeholders try to accommodate these trends by altering news distribution channels or through the personalization of the news stream. Central Europe is no exception to this phenomenon.

- What implications do these trends have for business?
- How do they influence politics, and in global terms, democracy?
- Is more-affordable access to news an opportunity or threat for investors?

# **Balkans: The Changing Role of the Media**

The media in the Balkan region is suffering from the economic crisis, a lack of professional tradition and from media corruption. Together, they result in financially exhausted and frustrated journalists dependent on sponsors and owners. As a consequence there is a chronic loss of public trust in the media. Readers and viewers see journalists as influenced by various interest groups and politics, and as a corrupt force.

- Can this crisis of confidence in a key institution harm democratic development?
- Are there any bright spots on the Balkan media scene that can serve as a model for others?
- Will EU accession play any role in altering the media in these countries?

#### **Media and Education**

Contemporary media has an enormous ability to shape the minds of readers, listeners, viewers, and users, which suggests a potential for educating people. But media and education are hardly synonymous. When media seeks to entertain it does not necessarily educate and as the volume and variety of media grow it seems much of it could actually detract from studying and actively learning. Still, the enormous power of 21st century media and new technologies, especially in an age of austerity, offer new opportunities for education, including books and university lectures, for example, to people lacking such access before.

- Can contemporary media play a role in educating new generations? What?
- Can a homo eruditus and an open-minded citizen of the world ever be a product of media (especially if they combine their efforts with educational institutions)?

 Is there a danger that media overload "dumbs us down" rather than "smartens us up"?

# Media and Freedom

#### **Media and Freedom**

Freedom of expression is regarded as the "first freedom" for a reason. Free media are indispensable for the maintenance of democratic societies. While the growth of the Internet, satellite TV channels, and social networks has enabled an unprecedented flow of information, censorship and media manipulation remain features of the information landscape. In fact, according to various global freedom indices, the proliferation of new technologies is not propelling greater political freedom.

- What are the main challenges to media freedom in modern, pluralistic societies?
- What are the implications of the greater fragmentation associated with the rapid development of media technologies? Are these developments good for democracy?
- What are the principal, new ways that governments, or even businesses or interest groups, are making media less free?

# The Persistent Influence of State-Dominated Media and the Challenge to Democracy

In cooperation with International Forum for Democratic Studies, National Endowment for Democracy

Authoritarian regimes make management of news media a priority for a reason. For most authoritarian states, state media has been crucial for regime survival by creating an alternate reality for their populations. State dominance of the media allows repressive regimes to deprive alternative voices of a mass audience and systematically exclude meaningful criticism from the airwaves. In Russia, for example, roughly 75 percent of the population gets news and information from television, where news content is effectively under the control of the authorities. While the Internet and other technologies have created opportunities to challenge state media hegemony, prospects for democracy in authoritarian settings are directly challenged by the persistent influence of state-dominated media.

- How should we assess the impact and influence of state media dominance in authoritarian regimes?
- What are the implications of continuing state media dominance?
- How can democratic reformers in authoritarian settings more effectively challenge the narratives that attack civil society and the democratic idea?

# **Censorship on the Internet**

Both the European Union and the United States have adopted official policies to aid Internet users and cyberactivists living in authoritarian regimes. Such thinking emphasizes a correlation between Internet access and political freedom. As technology advances and blanket censorship firewalls become more difficult to implement, it seems likely that authoritarian governments may resort to alternative tactics, including using citizens to monitor one another, paralleling surveillance techniques used in other areas.

- What methods are used to censor the Internet? Are they changing?
- What can activists and NGOs do to overcome censorship?
- How can the international community constructively promote the free flow of information in closed societies?

### **Cuba: Public Space in a Closed Society**

In cooperation with People in Need

The Cuban government fears independent information and at the same time, it is a valued commodity among Cuban citizens. Apart from bringing practical information, like where to get butter on the black market, it encourages critical thinking. In Cuba, public media is supervised by the government and filled with excerpts from Fidel Castro's lengthy speeches from the early 1980s. Add to this a heavy dose of sporting news and the always excellent results of Five Year Plans and the mass media offers little of value. However, such an environment has also spurred a vibrant alternative media landscape. These journalists are oppressed and persecuted, but manage to survive on recycled paper and burned CDs. Their growing readership points to big underlying potential.

- What is the future of alternative media in Cuba?
- Can this media play a role in changing political conditions?
- Is there a role for the international community to play in fostering such efforts?

# Freedom of the Press, Poverty and Democracy in Africa

Media are in the forefront of the fight for democracy in Africa, but media have also at times played a negative role as it was utilized as an ideological tool and brought under state control. African journalists operate under some of the most restrictive conditions anywhere and many face imprisonment or even death while doing their work. The condition of African media closely correlates to economic, social, and political problems. Governments have not promoted the political and economic climate which would lead to independent, critical, and

economically viable media. On the contrary, they justify press restrictions by invoking the primacy of economic development.

- What is the potential of new media, including the Internet, in sub-Saharan Africa?
- What are some of the external influences on African media?
- What role do economic conditions play in free media development?

# Opening Closed Societies by Protecting Persecuted Journalists, Editors and Bloggers

In cooperation with Freedom Now

Perhaps the most important way repressive regimes seek to maintain their hold on populations is by severely restricting access to information. Specific measures are often taken to target distribution channels, such as shutting down newspapers, jamming radio broadcasts and censoring the Internet. Those who dare to run news organizations or report the news in repressive societies are at risk of being jailed, intimidated, harassed or even killed. The international community can play a role in supporting courageous individuals whose lives are at risk because of their work.

- What are the global trends regarding persecuted journalists? How many are killed, imprisoned, or otherwise intimidated and how has that changed over time?
- What are the most effective strategies for countering enhanced repression of the media?
- How can defending these persecuted individuals open greater space for access to information in closed societies?

# Accessing Free Information in China: Challenges and Perspectives

Article 35 of the Constitution of the People's Republic of China claims that, "Citizens enjoy freedom of speech and of the press." Strict censorship, nevertheless, is widespread in China and people like Chen Wei are jailed for "subversive" writing when publishing essays on the Internet issuing public calls for greater freedom of speech. According to Amnesty International, China "has the largest recorded number of imprisoned journalists and cyber-dissidents in the world." The governmental authorities not only block website content (references to democracy, Free Tibet, the Arab Spring etc.) but also monitor the Internet access of individuals.

- What is the real situation of freedom of speech and the press in China?
- Is there any trend of growing freedoms alongside economic reforms? Is a shift in the future possible?
- How can the free and democratic societies from the

international community support the liberalization of the Chinese media scene?

# **Democracy and Media in Russia**

Over the past year, Russia has witnessed a wave of unexpected and massive public protests over the conduct of elections. This brought hundreds of thousands of people to the streets, generating scenes unseen in Russia during the past two decades. It lead to a swift response from authorities worried by the sudden upsurge in civic activism. A new anti-demonstration law, the reclassification of certain NGOs as "foreign agents," and the criminalization of defamation in the trial of members from the Pussy Riot punk group are all signs of the forces of repression fighting back.

- What is next for the political evolution of Russia, more pluralism or continued repression?
- What role can the media play in shaping or following these developments?
- Do Russians have access to free information? And can they use this information to influence decision making?

# The Role of Media in Burma on the Path to Democracy

In cooperation with People in Need

Burma has gone through unexpected changes for the past two years, but many remain cautious as the transition to a freer society is largely managed by the same people who have aided one of the world's most brutal dictatorships for several decades. In short, serious issues still persist. And yet, there have been a number of positive reforms and changes, many of which were almost unthinkable until recently. Chief among these was the abolishment of government censorship. This shift opens increased room for media to play a pivotal role in democratic transition and can also help the public understand reforms, providing space for reactions, opinions and discussion.

- How can media help Burma on its path towards democracy?
- Is media an observer to or participant in democratic reforms?
- Does the risk remain that the government could return to more restrictive measures in dealing with the press?

# Today's Media: Symbol of Freedom or Manipulation?

In cooperation with Antiquarian Bookshop Fiducia

Media is traditionally understood as a watchdog of democracy. However with the rise of professional public relations and new channels of communication there seems at least a potential that media can be used as a tool for manipulation. Furthermore, information that can inform the public and thus empower them to make political decisions can be drowned out by entertainment. The landscape has changed, and media professionals must adapt as well.

- Can new media play a role in overcoming public relations spin of the news?
- Do the media help to describe reality or are they creating a reality of their own?
- Is publicly important information completely separate from entertainment? Should it be?

# Media and Responsibility

### **Open Data: A Tool For Transparent Politics?**

In cooperation with Open Society Fund Prague

The Open Government Partnership initiative was launched one year ago and both the Czech Republic and Slovakia have resolved to open government data to citizens. They are following an idea that believes open data promotes transparent business, academics and governance, but this is hardly a consensus. Experts offer passionate polemics on the subject.

- Is there any evidence that new technologies are making government more open?
- Are citizens ready and able to make sense of the data at their disposal?
- How open can a private sector based on intellectual property be?

# Public, State and Government Media: Where Are the Boundaries?

In cooperation with Czech Radio-Rádio Česko

There are many different models of financing, overseeing and running publicly-funded media. Each such model potentially limits impartiality, independence and editorial values. At the same time the kind of news and information broadcast by some state media is of the type that for-profit media ignore, even as it is essential to informing citizens.

- Who "owns" public broadcasters taxpayers or political elite?
- Which safeguards should be in place and what works best? Is there still a need for publicly-funded media?
- Is there an audience for serious news and current affairs programs?

# **Human Rights and the Media**

Media can play a powerful role in defending human rights. It may help to protect dissidents, activists, and political prisoners, and even contribute to democratic change in a country. However, media can also contribute, sometimes unwittingly, to discrimination, hatred, and human rights abuses. During the Dreyfus affair at the turn of 19th and 20th centuries, anti-Semitism was fomented by newspapers; during the Rwandan genocide "hate media" played a crucial role. In Central Europe today, the media treatment of Roma community is often a cause for criticism and concern and in some countries, leprosy, a disease that became curable 20 years ago, is still a cause for stigmatizing and ostracizing entire communities.

- What are the root causes of discriminatory attitudes towards ethnic or minority groups in media?
- How can media avoid encouraging the exclusion of specific groups from mainstream society?
- How is the situation changing with the transforming media landscape?

# **Politics of Image**

What started with Richard Nixon's unshaved face in a televised US presidential debate continues. Looking at the young handsome appearance of Tony Blair or David Cameron, one wonders whether Winston Churchill could become Britain's Prime Minister in today's era of telegenic politicians. It often seems that image, rather than ideas, plays the preeminent role in politics today.

- Has responsible governance given way to governing by opinion polls?
- Is there a crisis of political leadership or a crisis in belief in politics as a solution?
- Is the media at fault for such developments?

### Do We (Still) Trust Media?

Anybody can manipulate photographs on a laptop these days. Millions of people can disseminate their views around the globe, blurring the borders between their Facebook profiles, blogs, and established media. Our cell phones are an open book to a certain kind of competitive journalist. Governments, even in democratic countries, do their best to influence their media image. The public, on the other hand, grows increasingly skeptical about traditional media.

- How is the perception of the media in society changing?
- Can we believe what we hear and see in the media?
- How do we know that the news we receive is accurate and impartial?
- Do we need new ways of controlling powerful media concerns?

# Media, Responsibility and Ethics

The Western media tradition is based upon the Judeo-Christian concept of truth as a creative ethical principle. One of the key notions of media practice is that information (emanating from the Latin *in-formatio*) plays the role of educating its recipients. Media shapes public opinion, the value systems of individuals, as well as societies, and in many respects creates the essence of a culture. As a kind of arbitrator of truth, media enjoy considerable prestige and power, but also a high degree of responsibility.

- To what extent does the media today realize this responsibility?
- Are the truth and media information increasingly drifting apart? Is there one truth?
- Media can form, educate, entertain, or even manipulate – where is the balance shifting?

# Media, Culture and Civil Society Development

In cooperation with Pilsen 2015 and Faculty of Philosophy and Arts, University of West Bohemia, Pilsen

There is some logical tension between a culture where people cultivate their own opinions, with diverse results, and one where common cultural codes are transferred via mass media. In short, media has tremendous influence on the development of civil society. This relationship is changing with the development of new media, as traditional social structures and means of communication become atomized.

- How does media contribute to the creation of cultural codes, norms and values?
- Can culture in this context act as a kind of social cement any longer?
- Is the use of new media a cultural feature in its own right?

### Social Responsibility of the Media

In cooperation with Institute for Public Affairs, Bratislava

Social responsibility is normally associated with media only as carriers of such information. If they distribute useful, unbiased information, many consider the media as playing a socially responsible role. However, it seems there is also a role for media to promote social responsibility in society at large.

- Is media doing its job if it is not promoting general social responsibility?
- Are the values of social responsibility universal or are they disputed?
- To what degree is media already meeting its social responsibilities?

# Media and the Economy

# Towards A Green Economy and Sustainable Future: Role of the Media

In cooperation with UN Information Centre Prague, Embassies of Brazil, Germany, United Kingdom and Heinrich Böll Foundation

There were more than 4,000 journalists in Rio de Janeiro to cover the UN Conference on Sustainable Development. Globally, more than 160,000 articles were published on Rio+20 and a green economy is fast becoming a key component of mainstream economic discourse and seen as a blueprint for achieving sustainable growth. Still, there is a sense that other forms of economic thinking prevail in much of the mainstream media and there seems a role for journalists and broadcasters to bring more awareness to environmental issues as they intersect with changes in society.

- Is the media engaged enough in this subject?
- What can we learn from international best practices when it comes to transitioning to more sustainable economies?
- Can the media help shape a sustainable future agenda and connect the three pillars of sustainability – economic, environmental and social?

### **Changing Media Business Models**

In cooperation with Transitions (TOL)

Large labor-intensive media outlets continue to look for new ways to finance their operations in the face of a proliferation of smaller, more agile, often Web-based competitors. At the same time, the big players, and their newsgathering operations, remain the foundation of informing the public and often even provide the source material for their smaller competitors. Effectively gathering news is contingent upon being able to finance that work, and as people get their information in new ways there is a vast amount of experimentation underway in how to adjust to this new reality.

- Will people pay for news?
- Is there a way to maintain traditional newsgathering strength within new revenue models?
- What happens if the role traditionally played by print newspapers, and other established outlets, disappears?
- Is there a way to mix the speed and networkability of the Internet with slower, more thoughtful journalism?

# **Media, Economy and Politics**

In cooperation with the Center on Global Economic Governance, Columbia University

Media, business and politics are closely intertwined. The media plays an important role in forming public opinion, which in turn affects political preferences. Meanwhile, political leaders create a framework for doing business. A poorly performing economy is a recipe for electoral defeat and media reporting can dramatically influence market conditions. At the same time, businesses are dependent on a positive reception from the public, which often comes through information in the media. To close the loop, business conglomerates with core interests in other industries often acquire media outlets in an attempt to positively influence their public image.

- What are the main risks in this constant interaction between the economy, media and politics?
- Have the scandals at News Corp. in the UK had a long term impact? What about elsewhere in the world?
- What will be the impact of the "democratization of the media" wave with growing content choice on satellite channels and the rise of social networks?

# **Special Focus**

#### **Issues and Solutions for the Bottom Billion**

In cooperation with The Sasakawa Peace Foundation

Globalization has played an important role in reducing the number of people living on or under US\$1.25 a day. But it has not reached the poorest parts of the population, the so called "bottom billion." It is suggested that a more inclusive policy framework for globalization is necessary to address these effects and the international aid system needs to pay greater attention to the poorest parts of the population. The UN Millennium Development Goals have played a significant role in encouraging a reduction in the number of people living in destitute conditions. But the broader original goal to improve the social and economic conditions of the poorest countries and societies still remains to be achieved.

- How has globalization increased inequality and impacted the bottom billion?
- What are the most urgent issues at stake for people living in extreme poverty?
- Are there any potential solutions to bring the bottom billion into the global economy?
- What kind of new aid system is needed after the MDGs to contribute to a just, inclusive and sustainable pattern of global development?

# **Tibet: A Way Forward**

In cooperation with Potala

For more than a half century there has been cultural and political tension on the Tibetan Plateau. The situation has taken on increased urgency as dozens of acts of self-immolation have taken place in the last year to protest heavy-handed Chinese government policy. The Tibetan language, culture, religion, heritage, and environment seem to be under increased pressure.

- What are the main problems Tibetans are facing?
   What are possible solutions?
- What are the aims of resident Tibetans and Tibetans in exile? Are they the same?
- What role is there for the international community?

# **Hungary: Still a Democracy?**

With a two-thirds parliamentary majority, the Hungarian government of Viktor Orbán has seen foreign observers accuse them of building a regime with authoritarian features. While the critiques vary, limits on media freedom have drawn particular attention. The government has shown a questionable understanding of liberal democracy and economic policy, but foreign critics have also demonstrated a lack of knowledge about Hungarian society and history, where the roots of recent government policies lay. As a result, the picture of a more and more internationally isolated Hungary emerges at home as well as abroad.

- Is the Western (liberal) model of development discredited in the eyes of most Hungarians? What do disputes over the media law show?
- Is the foreign perception of Hungary close to reality?
   Is the international community able to understand the average Hungarian?
- Is this first example of a post-communist transition based on liberal values being over-powered by deeper traditions based in nationalism?

# **Prague Enlargement Dialogue**

In cooperation with Ministry of Foreign Affairs of the Czech Republic, European Commission Representation in the Czech Republic, Institute of International Relations, EUROPEUM

The Prague Enlargement Conference follows the introduction of the October 10, 2012 European Commission enlargement report. Its presentation in Prague will be accompanied by a political and expert conference, which would evaluate the perspectives of enlargement process in the context of the current strategic debate on the future of the European Union. The event will seek to underline the importance of the enlargement policy as well as its compatibility with further integration of the EU. Another goal would be to show the enlargement policy

as a policy with positive pro-growth impact through expansion of the internal market and creating new business opportunities.

#### **Women Leaders Panel**

In cooperation with Forum 50%, Open Society Fund Prague and Friedrich Ebert Foundation Representation in the Czech Republic

The representation of women in decision-making bodies is low. This applies both to politics, where the international average share of women in parliaments is 20 percent, and business, where women comprise just 13.7 percent of company boards. Nonetheless, some women still manage to break through the so-called glass ceiling to reach leadership positions, and thus have personal experiences and expertise to share.

- What are the root causes of this gender unbalance?
- Does the media play a role by making women invisible?
- Are there policy solutions, like quotas, that can help rectify the lack of balance?

### The Nile River: A Problem That Is Not Drying Out

In cooperation with The Coca-Cola Company

The Nile River is the longest river in the world. Its basin covers huge territory, spanning 10 African countries. For Egypt, the importance of the Nile is tremendous, as roughly 95 percent of Egypt's population lives in the Nile Valley. This makes Egypt particularly vulnerable as it relies on fresh water that comes from outside its borders. The Egyptian population is growing and the Nile River is already hardly able to provide enough fresh water for all its dependents. Therefore, Egypt's ability to deal with the water scarcity is likely to be a major test for its political leaders.

- What are the water plans of the new Egyptian government?
- Will the Nile River be a source of cooperation or conflict among African countries?
- How to reconcile the national development needs of the Nile basin countries without threatening political and environmental stability?

#### **Venezuela After the Presidential Election**

The session takes place in the wake of a closely watched electoral contest won by long-time president Hugo Chávez over the opposition candidate, Henrique Capriles. Now, President Chavez is likely to face a fractured society in dire need of reconciliation. The session will offer an insight into both the imminent political fallout as well as more long-term ramifications for Venezuela's future.

- What policy priorities is the President Chavez likely to pursue?
- What does the conduct of the election tell us about the current state of Venezuela's democracy?
- How will the losing side cope with its defeat in the election? How will this affect the country's prospects for long-term political stability?

### Women's Congress

In cooperation with Forum 50%

A consortium of organizations and personalities from academia, NGOs and the commercial and artistic spheres gather to discuss the unique challenges faced by women. The main aim is to raise awareness about the persistent inequalities between men and women within Czech society. This open working meeting is a preparatory event aiming to develop a complex strategy for the first Czech Women's Congress, which will include the participation of foreign and Czech experts from business, politics and culture.

# Multispeed Europe and the Eurozone: A Central European Perspective

The multispeed integration process is becoming more visible in the European Union and our region has never been more split. The Slovaks, who have already joined the eurozone, act loyally, The Poles still have not joined the eurozone, but call for greater integration in Europe. The Czechs have not joined the eurozone and have no interest even in a fiscal compact.

- Why do Central European countries have such different opinions on European integration?
- We are able to criticize European project, but why do we not feel obligated to come up with constructive solutions?
- Should Poland, Slovakia and the Czech Republic try to find some common interest as far as European integration is concerned?

# The Future of Education, A Central European Debate: Corruption

In cooperation with Goethe-Institut

Education and vocational training are undergoing a profound transformation and the societies of Central and Eastern Europe are facing new challenges in relation to these shifts. The integration of minorities, social permeability and accessibility to the education system as well as the transition to new technical and societal demands on graduates are just a few of the numerous issues to address. It is against this background that the "Future of Education" project was initiated by the Goethe-Institut branches in the Czech Republic, Estonia, Hungary and Lithuania in order to provide a forum for discussion of possible solutions and exchange of experiences between

the countries. This discussion will take place in two panel sessions.

- What is the relationship between education and corruption?
- What are the roots of corrupt behavior in societies?
- Are there opportunities to address these issues as education undergoes a fundamental shift?

# The Changing Role of Intellectuals in Today's World

In memory of Professor Jiří Musil

The interconnection of continents and cultures helps to spread ideas, open new horizons and share opinions. It also helps transmit emotions, making both fear and resilience particularly contagious. In a multimedia age, a flood of words and images often makes it difficult to decide what is and isn't relevant. It would seem there is a role for intellectuals in helping society focus on what really matters, and translate words into political or citizen action. The need to focus on what really matters is more important than ever, and would allow resilience to overcome fear.

- How to face fear and contribute to spreading the culture of resilience and empowerment?
- How do we focus the public sphere on things that really matter?
- Can intellectuals drive dialogue toward a more result-oriented political debate?

# Democracy: Challenges From Demagogy and Extremism

Extremist or populist currents seem to be on the rise in parts of Europe. It can be argued that electoral results of populist extremist parties, such as Jobbik in Hungary, the National Front in France, the Communist Party in the Czech Republic, the Party for Freedom in the Netherlands and so on, present a pressing challenge to European democracies. The current economic slowdown may prove fertile ground for a further increase in support for similar political forces and social movements.

- Is the influence of extremists in Europe really on the rise?
- If it is, are democratic institutions ready to face it?
- What can be done to counter these trends?

## **Ukraine: Democracy on the Borderline**

In cooperation with Heinrich Böll Foundation and Na Východ magazine

President Viktor Yanukovych and his Party of Regions have been accused of constitutional violations, oppressing political opponents, harassing independent media, limiting freedom of expression and undermining democracy. In

recent months prison sentences for former members of the previous government, the death of a notable human rights and environmental activist and continued pressure on independent media raise questions about whether Ukraine is drifting away from democracy and close to authoritarianism.

- To what extent do these labels and accusations reflect reality?
- Is the international community doing enough to push for change?
- How much does the average Ukrainian care about such issues?

# The Role of Civil Society in EU External Relations

In cooperation with DEMAS and the European Commission Representation in the Czech Republic

Non-governmental organizations play an important role in shaping the external relations of the European Union, in particular in the fields of human rights and democracy assistance. NGO advocacy practitioners who work on the Brussels level gather with Czech and Slovak NGOs, exchanging experience and expertise. As EU values and practices become increasingly codified internally, they can equally serve as a model for nearby countries.

- What are the main approaches and instruments in influencing the decision making on the EU level?
- What should be the main focus of civil society vis-avis the EU external action in the near future?
- How can civil society advocacy be made more relevant?

# **The Czech Female President Platform**

In cooperation with Česká prezidentka (Czech Female President Platform)

Czech society seems to have very limited experience with open-mindedly, publicly and systematically debating alternative visions for its long-term development, let alone for finding generous time to listen to visions outlined by women – whom are underrepresented politically. Neither the media nor political campaigns address this. The symposium gives the floor to selected key public female figures who will speak on their personal thoughts and experiences. All speakers get fifteen minutes to present their personal vision for the future development of the Czech Republic. The long term goal is to support the election of the country's first female president. Personalities from different fields of Czech society are invited to speak.

# 3 Minutes to Change Their Lives: Campaign for the Release of 3 Prisoners of Conscience

In cooperation with Amnesty International Czech Republic

Every year, thousands around the world are arrested solely because of their opinions and beliefs. Amnesty International calls them "prisoners of conscience" and has succeeded in saving some 50,000 of them. This year's "3 Minutes to Change Their Lives" campaign aims to help three unjustly imprisoned people: Behare Hedajat, an Iranian women's rights activist; Tibetan filmmaker Dhondhup Wangchen; and Cameroonian student Jean-Claude R. Mbede, convicted for alleged homosexuality. The aim is to gather as many signatures as possible to put pressure on governments to release the prisoners. Speakers and visitors are invited to sign letters in their defense. Helping them may be easier than it seems. For more information, visit www.3minutystaci.cz.

### **Tibetan-Burmese Hopes**

In cooperation with M.O.S.T. and People in Need

A camera flash can shed light on overlooked corners of the world. This exhibition seeks to represent Tibet and Burma from various points of view and bring spectators into the life stories of individual Tibetan and Burmese people. While intimate, the scenes reflect global problems as they are experienced on the ground and force the viewer to confront issues that result from human rights violations, armed conflict and migration. Images depict the cultural and political situation in ways that words never could, while the text accompanying the photos provides information on development and aid projects.

## Life As I Know It: A Glimpse Into the Roma Community

In cooperation with Talitha Brauer and the St. Martin in the Wall Church

Long a minority group that has faced discrimination and social exclusion, the exhibition documents the daily existence of the Czech Roma community, with a focus on the home environment. Photos are accompanied by interviews, which add additional perspective to the Roma experience. There is beauty and dignity in the lives depicted in this work, but it does not idealize or exaggerate the difficult living conditions many in the Roma community face.

## **Cartographies of Hope**

In cooperation with DOX Centre for Contemporary Art

Some argue that we are living in the era of rising inequality and thinning social cohesion. To simply critique and historicize the system is not enough. We need to connect dispersed narratives into a coherent whole – a metanarrative that would provide us with a sufficient social cohesion on one hand, and openness and hope on the other. The exhibition is organized in several sections and subsections that represent diverse narratives of change, while their sum and sequence indicate a larger picture that may show a direction to a new metanarrative.

# National, European and Human Security: From Co-existence to Convergence

This book presentation, and accompanying discussion is focused on the text "National, European and Human Security: From Co-existence to Convergence," edited by Mary Kaldor, Mary Martin and Narcis Serra and published by Routledge this year. **Madeleine Albright**Former Secretary of State, USA

Former Secretary of State, Professor of International Relations at Georgetown University, Principal of The Albright Group LLC, a global strategy firm, and

Chair and Principal of Albright Capital Management LLC, an investment advisory firm focused on emerging markets. In 1997, she was named the first female Secretary of State and became, at that time, the highest ranking woman in the history of the US government. As Secretary of State, she reinforced America's alliances, advocated democracy and hum an rights, and promoted American trade and business, labor, and environmental standards abroad. From 1993 to 1997, Dr. Albright served as the US Permanent Representative to the United Nations.



**Yuri Andrukhovych** Writer, Poet, Ukraine

A writer and poet, Andrukhovych's latest book is "Lexicon of the Intimate Cities" (2011). He was born in 1960 in Ivano-Frankivsk, Ukraine and in 1985

founded the popular literary performance group "Bu-Ba-Bu" (Burlesque-Bluster-Buffoonery). He has published four poetry books – "The Songs for a Dead Rooster" (2004), "Exotic Birds and Plants" (1991, with new editions 1997 and 2002), "Downtown" (1989) and "Sky and Squares" (1985); five novels – "A Mystery" (2007), "12 Rings" (2003), "PerverZion" (1996), "Moscoviada" (1993), and "Recreations" (1992); and two collections of essays – "The Devil is in the Cheese" (2006) and "Disorientation in Locality" (1999).



**Michael Anti** Journalist, Political Blogger, China

Journalist and Political Blogger for various Chinese and English-language media outlets, he is an Associate Fellow with the Asia Society. As a public

advocate for Internet freedom and online public diplomacy, he is one of the most influential microbloggers in China. He worked as a reporter in Baghdad and also at the Beijing Bureau of The New York Times. Mr. Anti has received Wolfson Press Fellowship at Cambridge University (2007), Nieman Fellowship at Harvard University (2008), and was a visiting scholar at University of Tokyo (2010). He was awarded M100 Sanssouci Media Award in 2011 and has a degree in International Reporting from the Journalism School of Shantou University.



**José Maria Argueta** Secretary of Strategic Intelligence, Guatemala

Former and first civilian National Security Adviser of Guatemala as well as former Ambassador to Japan and

Peru, he is currently Secretary of Strategic Intelligence Secretariat, in Guatemala. He co-authored and implemented the ESTNA Methodology, a conflict resolution method that facilitated the peace processes of Guatemala and El Salvador. As Ambassador to Peru, he was among the lead negotiators who helped to free hostages captured in the Japanese Embassy (1996). He has served as a consultant to the Inter-American Development Bank, Harvard University's Center for Conflict Resolution, and the National Endowment for Democracy. He is the author of "Enlightened Dissent: A Leadership Methodology for Peace Building" (2008).



**Aliaksandr Atroshchankau** Journalist, Former Political Prisoner, Belarus

A journalist for Charter 97 for ten years, he was also a spokesman for the group European Belarus. During

the Belarus presidential election campaigns of 2010, Mr. Atroshchankau was a spokesman for Belarusian Presidential Candidate Andrei Sannikau. In December 2010, he was arrested covering the post-election demonstrations and later he was sentenced to four years in prison. In September 2011 he was released along with 10 other political prisoners.



**Aung Zaw**Founding Editor and Director, The Irrawaddy, Thailand/Burma

Founding Editor and Director of The Irrawaddy newsmagazine, he also founded the Burma Information Group

in Bangkok to shed light on human rights violations in Burma. Aung Zaw previously worked as a correspondent for Radio Free Asia and contributed to The Nation, Bangkok Post and the Asian edition of The Wall Street Journal. As a student he was an activist and organizer of opposition to the Burmese military government.



**Shlomo Avineri** Professor of Political Science, The Hebrew University of Jerusalem, Israel

Professor of Political Science at the Hebrew University of Jerusalem and member of the Israel Academy of

Sciences and Humanities, he served as Director-General of Israel's Foreign Ministry (1975–1977) and held visiting

positions at Yale, Oxford, University of California and the Central European University in Budapest, among other places. Mr. Avineri is a recipient of the Israel Prize, the country's highest civilian decoration. His widely translated books include: "The Social and Political Thought of Karl Marx" (1968), "Israel and the Palestinians" (1971), "Hegel's Theory of the Modern State" (1974), "The Making of Modern Zionism" (1981) and "Herzl: An Intellectual Biography" (2007). He is a graduate of the Hebrew University and the London School of Economics.

He gained prominence through his studies on the connection between the culture of modernity and totalitarianism. He became known for works such as "Legislators and Interpreters"

(1987), "Modernity and the Holocaust" (1989), "Modernity and Ambivalence" (1991) and "Postmodern Ethics" (1993). His most recent publications are "Collateral Casualties of Inequality" (2011), "Education" (with Riccardo Mazzeo, 2011), "Culture in Liquid-Modern Times" (2012), and "This is not a Diary" (2012).



Ales Bialiatski

President, Viasna Human Rights Centre, Belarus

Ales Bialiatski was invited to this year's Forum 2000 Conference, but is unable to attend as he remain imprisoned for

political reasons.

President of Viasna Human Rights Centre (since 1996) and Vice-Chairman of International Federation for Human Rights (since 2011), he was a nominee for the 2012 Nobel Peace Prize. Mr. Bialiatski was arrested by Belarusian authorities on tax evasion charges in 2011 and sentenced to four-and-a-half years in prison, which has been widely recognized as a political act considering his devotion to human rights in Belarus. Mr. Bialiatski's imprisonment has been followed by numerous appeals from international organizations for his release. He has won multiple awards, including the Homo Homini Award and the Per Anger Prize for his efforts in promoting human rights and democracy. In September 2012, Mr. Bialiatski was announced the winner of the Lech Walesa Award. He holds a Ph.D. from the Belarusian Academy of Sciences.



Igor Blaževič

Founder, One World Film Festival, Czech Republic/Bosnia and Herzegovina

Founder of One World Film Festival, the biggest human rights film festival in Europe, he is also a steering commit-

tee member of World Movement for Democracy, and was formerly Director of the Human Rights and Democracy Department of People in Need (1994–2010). Mr. Blaževič studied Philosophy and Comparative Literature at Zagreb University.



Endre B. Bojtár

Editor-in-Chief and Publisher, Magyar Narancs, Hungary

Editor-in-Chief and Publisher of Magyar Narancs since 1999, as a journalist he has written on Central Europe, the

Balkans, Bulgaria, Ukraine, Lithuania and Northern Ireland. He published a book of reportage on Central Europe, "Sins Without a Master" (1999). Mr. Bojtár also has an interest in examining the national myths of Central and Eastern Europe as well as the dynamics of ethnic tensions and conflict.

Communications Director at Piano Media, he was a professional news photographer for nearly 20 years

Professor, Graduate School of Economics and the Faculty of Economics at the



Before relocating to Canada, Ms. Knežević lived in Bosnia, where she was the Deputy Editor of Oslobodjenje, an internationally recognized Sarajevo-based daily that never stopped publishing during the Bosnian War. For her work there, she received the Courage in Journalism Award from the International Women's Media Foundation.



Ko Ko Gyi

1988 Student Leader, Burma

In 1988 as a final year student at the University of Rangoon's International Relations program, Ko Ko Gyi led peaceful rallies on the university

campus. He was actively involved in the 8-8-88 uprising and was appointed the Vice-Chairman of the All Burma Federation of Student Unions (ABFSU). In December 1991, he was arrested for participating in a student gathering at the University of Rangoon to celebrate Aung San Suu Kyi being awarded the Nobel Peace Prize, which resulted in a 20 year sentence of hard labor. He was released in March 2005. His most recent incarceration came in November 2008, when he was sentenced to 65 years in prison. He was released in January 2012 and is again active in politics.

**Kyaw Thu** 

Director of Paung Ku, Burma

Director of Paung Ku, and organization he founded in 2011. The group is a civil society strengthening project that provides funding and capacity building to local civil society organizations. Their work focuses on poor and marginalized communities with an emphasis on improving the delivery of services, strengthening networking and organizing advocacy projects.



Ales Lahviniets

Activist, Movement for Freedom, Belarus

Activist with the Movement for Freedom in Belarus, since 2007 he has worked as an advisor to Dr. Alyaksandar

Milinkevich. Mr. Lahviniets has run as a candidate for several recent elections in Minsk. He is also a lecturer, political commentator and the author of a number of articles on the politics foreign policy of Belarus. He has an M.A. in Political Science from Institute for Political Studies in Strasbourg, a Diploma from the Polish Diplomatic Academy and is currently a Visiting Scholar at the Jagiellonian University.

**Liu Xiaobo** Literary Critic, Writer, Professor, Nobel Peace Prize Laureate, China

Liu Xiaobo was invited to this year's Forum 2000 Conference, but is unable to attend as he remains imprisoned for

political reasons.

Nobel Peace Prize Laureate, he was awarded the 2010 Nobel Peace Prize for his struggle for fundamental human rights in China, while serving his fourth prison term. He is the first person since Von Ossietzky to be denied the right to have a representative to collect the Nobel Prize for him. Mr. Xiaobo was detained in December 2008 because of his leading role with the Charter '08 manifesto. Prior to that he was President and Editor-in-Chief of Minzhu Zhongguo (Democratic China) Electronic Journal, which promotes liberty, democracy, human rights, rule of law and constitutionalism. He served as President of the Independent Chinese PEN Centre (2003–2007) and has been a visiting scholar at Columbia University, the University of Oslo, and the University of Hawaii.



**Jan Macháček** Journalist, Respekt, Czech Republic

Journalist, musician and economic commentator for the daily Hospodářské noviny and the weekly Respekt. In 2000, he served as Deputy

Editor-in-Chief of Respekt and was awarded the Ferdinand Peroutka Award in 2009 for his writing. Mr. Macháček was a Fellow of the National Forum Foundation in Washington and of the William Davidson Institute at the University of Michigan. He lectured on the Politics and Economics of Transformation at the Anglo-American College in Prague and at New York University in Prague. He also serves as a board member of Transparency International, Czech Republic. Among a long list of accolades, he received the Sakharov Prize of the European Parliament in 2006. He holds a Ph.D. in Physics and Mathematical Science and regularly attends trainings and discussions in the USA, Germany, France, Belgium, the Netherlands, Poland and other countries with a focus on public administration, economic reform and human rights.

#### **Min Yan Naing**

Co-founder, Generation Wave, Burma

Co-founder of the pro-democracy youth movement Generation Wave, which was established in October 2007 in reaction to the Saffron Revolution. He and the other three co-founders were all activists involved with student demonstrations in 1996 and 1998. Generation Wave was initially formed by people between 15 and 25 years old, and much of their work involved new ways of spreading a pro-democracy message through hip hop music and the Internet.

Mr. Nesh Nash founded political crowdsourcing initiatives related to constitutional drafting, election monitoring and fighting corruption. In 1999 he ran as candidate of the People's Democratic Party (PDP) and was reelected in 2003. Later he was Chairman of the Board of Trustees of the PDP. Currently he is a member of the Africa Progress Panel and United Nation's Special Envoy to the Democratic Republic of Congo.



**Ruth Oniang'o** Executive Director, Rural Outreach Program, Kenya

Executive Director of the Rural Outreach Program, she was formerly a Member of Parliament (2003–2007),

also serving as Shadow Minister of Education. Ms. Onlang'o served on the boards of the Bill & Melinda Gates

Foundation's Agriculture Strategy Advisory Committee, International Fertilizer Development Center, the International Rice Research Institute and the International Food Policy Research Institute. He served as the member of Czechoslovakian Parlament after 1992 and was served as Minister of Interior and Vice President of the Senate. For political reasons, he was several times refused the admission for university studies and he earned a law degree at age 51.



**Yoani Sánchez** Blogger and Activist, Cuba

Yoani Sánchez has accepted the invitation to the Forum 2000 Conference but has been denied permission to travel by the Cuban government.

A Blogger and Activist, her blog is available worldwide in more than 20 languages. In 2008, Time magazine listed her as one of the world's 100 most influential people and she has received much international recognition for her work, including: the Ortega y Gasset Prize, Spain's highest award for digital journalism; the Maria Moors Cabot

Prize from Columbia University; the World Press Freedom Hero Award from the International Press Institute; and the Prince Claus Award from the Netherlands. Foreign Policy magazine named her one of the 10 Most Influential Latin American Intellectuals (2008), and one of the World's Top Dissidents (2010). She recently published a book in English "Havana Real."



**Lobsang Sangay** *Kalon Tripa, Central Tibetan Administration, India* 

Kalon Tripa for the Central Tibetan Administration, he previously worked as a Senior Fellow at Harvard Univer-

sity and organized conferences between the Dalai Lama and Chinese scholars. Mr. Sangay has lectured at various universities and think-tanks throughout Europe, Asia and North America as an expert on Tibet, international human rights law, democratic constitutionalism and conflict resolution. He is a member of the newly formed International Advisory Committee to the New York Stock Exchange Board of Directors. Mr. Sawiris holds a diploma in Mechanical Engineering with a Master's in Technical Administration from the Swiss Institute of Technology in Switzerland and a Diploma from the German Evangelical School in Egypt.



**Karel Schwarzenberg** *Minister of Foreign Affairs, Czech Republic* 

Minister of Foreign Affairs and Deputy Prime Minister and Chairman of the TOP 09 party. He has already served as

Minister of Foreign Affairs (2007–2009) and was a Member of the Senate of the Czech Parliament (2004–2010). He was President of the International Helsinki Committee for Human Rights (1984–1991) and former Chancellor to President Václav Havel. **Václav Sochor** Editor-in-Chief, Czech Radio – Rádio Česko, Czech Republic

Editor-in- Chief of Czech Radio – Rádio Česko, he previously headed the foreign news section for the BBC, work-

ing both in London and Prague. He has worked at TV Nova and helped launch the television station Z1, where he hosted a weekly program. Mr. Sochor directed the media and communication journal Strategie and moderated the program Media and the World for Czech Television.



**Nicéphore Soglo** *Mayor of Cotounou, Former President, Benin* 

Mayor of Cotonou since 2002, he was formerly President of the Republic of Benin (1991–1996). His 1991 election

victory over an incumbent president is seen as a major benchmark in the development of African democracy. Mr. Soglo has served as Executive Director of the Central Bank of West African States and as an Executive Director on the board of the World Bank. He used his position to launch the World Bank's efforts to promote economic development in Sub-Saharan Africa. His academic career includes a fellowship at the Center for International Affairs at Harvard University and teaching at the National University of Benin. Mr. Soglo was educated in France, attending the Sorbonne University, the University of Paris, and the University School of Administration there to receive degrees in French literature, as well as in private and public law.



**Radek Špicar** Executive Director, Aspen Institute Prague, Czech Republic

Executive Director, Aspen Institute Prague, he also serves as Vice-President of the Confederation of Industry

in Czech Republic. He previously served as Director of External Affairs at Škoda Auto, responsible for relations with public institutions at national and European level, structural funds and the Corporate Social Responsibility concept. He was Deputy to the Vice-Prime Minister for Economic Affairs of the Czech Republic. Mr. Špicar lectured at the Institute of Economic Studies at the Faculty of Social Sciences, Charles University in Prague and at the Diplomatic Academy Prague. He studied at Charles University and the University of Cambridge.



**Jiří Stránský** Author, Czech Republic

An Author, he is also Director Emeritus of the Czech Centre of the International PEN club. A former political prisoner, Mr. Stránský has focused his

literature on similar subject matters and his short stories were published under the title "Štěstí" (Happiness). His major works include the novels "Zdivočelá země" (Feral country) and "Auction", for which he subsequently wrote a film script and Czech Television broadcast as a series. Mr. Stránský is a recipient of Egon Hostovský Prize (1992), the French Order for Art and Literature (2002), the Karel Čapek Prize (2006) and in 2011 he was awarded the highest scout honor – the Silver Wolf Award.



**András Stumpf** Journalist, Heti Válasz, Hungary

A Journalist, he is responsible for home affairs at the weekly Heti Válasz since 2004. His articles – including reports, interviews and opinions are also pub-

lished every week on the Heti Válasz online news portal as well. Besides journalism, he works as a teacher in Heti Válasz Workshop and is a frequent analyst of politics on Hungarian television and radio shows. He received his diploma from the Péter Pázmány Catholic University majoring in Communication (Journalism) where he also studied German Language and Literature. In 2009, he received the Junior Prima Prize in the press category.



**SU Chi**Former Secretary General, National
Security Council, Taiwan

Former Secretary General of the National Security Council (2008–2010), he is a Professor at Tamkang University's

Institute of China Studies and Chairman of the Taipei Forum. Prior to this Mr. Chi served in numerous government posts including as a Legislator (2005–2008) and National Policy Advisor to the President (1997). He has a Ph.D. from Columbia University and also worked as a Research Fellow at Harvard.



**Tamara Sujú** Human Rights Lawyer, Venezuela

A Human Rights Lawyer, she is President of New National Awareness Foundation, which promotes human rights, and democratic principles and

provides legal support to political prisoners. Ms. Sujú is also founder of Fundapres O.S., a foundation that provides aid to prisons throughout Venezuela, and Director of the Ladies in White – a group of wives, mothers and daughters of political prisoners. She has a Law Degree from Universidad Católica Andres Bello in Caracas.



Jan Švejnar Director, Center on Global Economic Governance, Columbia University, USA/ Czech Republic

Founder and Chairman of the Executive and Supervisory Committee of

CERGE-EI –, he was runner-up in the 2008 Czech presidential election. Mr. Švejnar is Director of the Center on Global Economic Governance and Professor of International and Public Affairs at Columbia University. Prior to this he was the Director of the International Policy Center at the University of Michigan, where he was also a Professor of Business, Economics and Public Policy. He served as Economic

Advisor to President Václav Havel as well as the Founding Director of the Economics Institute of the Academy of Sciences of the Czech Republic (1992–1999). He has Ph.D. from Princeton University.



**Bohuslav Svoboda** Lord Mayor of Prague, Czech Republic

Lord Mayor of Prague since 2010, Mr. Svoboda is a doctor by training and has served in a number of leadership roles in the medical community. He

was previously Dean of the Third Faculty of Medicine at Charles University (2003–2010). He was also the first ever President of the Czech Medical Chamber (1992–1998) and was also Deputy Director of the Vinohrady Teaching Hospital. Mr. Svoboda is a graduate of Charles University.



**Erik Tabery** *Editor-in-Chief, Respekt, Czech Republic* 

Editor-in-Chief of the weekly magazine Respekt since 2009. Mr. Tabery has previously served as Deputy Editor-in-Chief of Respekt, where he also started

his journalistic career (since 1997). He focuses mainly on Czech politics and has authored several books on it, for example "Opoziční smlouva a její dědictví" (2006) on the so-called opposition agreement of the Miloš Zeman government and "Hledá se prezident – Zákulisí voleb hlavy státu" (2008) on the Czech presidential elections of 2008. He is a recipient of the Ferdinand Peroutka Award. Mr. Tabery studied Journalism and Politics at Charles University.



**Sava Tatić** *Managing Director, Sourcefabric, Czech Republic/Serbia* 

Managing Director of Sourcefabric, he previously led the development of digital technology solutions for news

media at Media Development Loan Fund (1999–2010). Mr. Tatić was Electronic Publications Editor and Associate Editor at Transitions (1997–1999) and Associate Editor at the Open Media Research Institute (1997–1998). Between 1992 and 1999, he was a writer and foreign correspondent at Vreme weekly. Mr. Tatić holds a graduate diploma in International Relations from the Paul H. Nitze School of Advanced International Studies and a Master's in Economics from the University of Belgrade.



Enrique ter Horst
Former United Nations Deputy High

Commissioner for Human Rights, Venezuela

Former United Nations Deputy High Commissioner for Human Rights, he

is also a lawyer and political analyst. Prior to this, Mr. ter Horst was the UN Secretary-General's Special Representative for Haiti (1996-1997). He has also worked as Special Representative of the Secretary-General for El Salvador and Chief of the United Nations Observer Mission in El Salvador. Mr. ter Horst has been an ambassador in the foreign service of Venezuela since 1986, serving as a Deputy Permanent Representative of Venezuela to the United Nations and a representative to the Commission on Human Rights. He has also held the position of a Vice President of International Fund for Agricultural Development.



**U Ohn Kyaing** 

Member, Central Executive Committee, National League for Democracy, Burma

A Member of the Central Executive Committee for the National League for Democracy, he studied journalism

before working for several newspapers and magazines. As a result of his participation in the People's Democratic Movement in 1988, he was forced to resign his position as editor for the Botathaung newspaper. In 1990, he was elected as Member of Parliament for the NLD, before being imprisoned and sentenced to 17 years for writing and distributing "seditious pamphlets and threatening state security." Since his release in 2005, he has been again active in NLD.



Jan Urban

Journalist, Member, Program Council, Forum 2000 Foundation, Czech Republic

Journalist and one of the leading dissidents during the communist regime,

he is a Professor at New York University in Prague. Mr. Urban was a member of the International Independent Commission on Kosovo and he worked in Iraq training journalists and on heritage preservation projects (2003–2006). He served as a war correspondent in Bosnia and Herzegovina (1993-1996) and was the Publisher of Transitions magazine (1997-1999). Mr. Urban made two documentary films on the Kosovo conflict an in November 1989, helped to found the Civic Forum, working as its spokesman. He studied History and Philosophy at Charles University.



Jaroslav Valůch

People in Need, Czech Republic

Launching a nation-wide governmental campaign focused on monitoring and mapping of hate crimes, he is a One World Social Innovation Program

Manager at International Human Rights Documentary Film Festival One World and co-organizes or facilitates variety of social innovation events in Czech Republic,

Bosnia, Kazakhstan and Moldova. Mr. Valůch provides consultations and trainings to activist initiatives in Central and Eastern Europe, the Balkans, Caucasus, Central Asia, Southeast Asia and elsewhere. He works closely with the media development organization Transitions (TOL). In 2010, he was a Fulbright Fellow at the University of Maryland. Mr. Valuch has worked in Burma and Haiti as part of relief efforts following natural disasters.



Magdaléna Vášáryová

Politician, Diplomat, Slovakia

Member of the National Council for the Slovak Democratic and Christian Union - Democratic Party (since 2006). Ms. Vášáryová served as State

Secretary at the Ministry of Foreign Affairs (2005–2006), as Czechoslovak Ambassador to Austria (1990-1993) and Slovak Ambassador to Poland (2000-2005). She was a candidate in the 1999 presidential election. She is the Founder and Director of the Slovak Foreign Policy Association and of the journals "Zahraničná politika" and "Slovak Foreign Policy Affairs". She has written five books related to diplomacy and etiquette.



Josefina Vázquez Mota

Politician, Businesswoman, Mexico

A Presidential Candidate in the 2012 elections, she ran for the National Action Party (PAN) in the 2012 elections. She began her political career

with PAN organization, eventually becoming a Member of Parliament as was the head of the PAN Parliamentary Group in the Chamber of Deputies, among other things. As an economist Ms. Vázguez Mota worked for various business organizations and was also formerly an editor for Novedades. She has an Economics degree from the Universidad Iberoamericana.



Franak Viachorka

Youth Leader, Filmmaker, Belarus

A member of the Young Front, he is a Founder and formerly the Chairman of the BPF Youth (2008-2009), the youth wing of the Belarusian Popular

Front. Beginning in 2007, he was involved in the BPF Party, first as a Member of the Board and then the National Council and finally Chairman of the Commission on Culture. In January 2011, Mr. Viachorka was elected an International Secretary for the Belarusian Movement, an opposition party. He has worked as a journalist and editor for several independent media outlets including BelaPAN, the monthly political newspaper Naviny BNF and the Belarusian Service of RFE/RL.



**Vintsuk Viachorka** *Opposition Activist, Belarus* 

An Opposition Activist, he is the former leader (1999-2007) of the major opposition party, Belarusian National Front. He previously worked as a Professor

at the Minsk State Pedagogical Institute and the Belarusian Humanities Lyceum, and as a Journalist and Deputy Chief Editor of the culture magazine Spadčyna. He was one of the founders of several youth cultural groups and organizations: Majstroŭnia, Tałaka, and the Confederation of Belarusian Juvenile Organizations. Mr. Viachorka is the founder and head of an educational non-governmental organization, the Supolnaść Center and was head of the working group of the NGO Assembly of Belarus (1999–2000). He graduated from the Philology Faculty of the Belarusian State University and the Linguistics Institute of the Belarusian Academy of Sciences.



**Marites Vitug** Journalist, Chair, Advisory Board, Newsbreak, Philippines

Chairwoman of the Advisory Board and a writer at Newsbreak magazine. Ms. Vitug has written for various global

media outlets, including The International Herald Tribune, Christian Science Monitor, Newsday, and Asahi Shimbun. In 2006, the Eurasia Group named her one of 50 Global Leaders for her work at Newsbreak. The author of several books, including "Shadow of Doubt: Probing the Supreme Court," "Power from the Forest: the Politics of Logging," and "Jalan-Jalan: A Journey through EAGA," she was a Nieman Fellow at Harvard University and holds a postgraduate degree in International Relations from the London School of Economics and a B.A. in Broadcast Communication from the University of the Philippines.

Deputy Europe Editor/Europe Online Editor for The Economist, she started to work for The Economist as a finance

Ms. Von Bredow took a leave of absence to write the authorized biography of Italian businessman Giovanni Agnelli. Before joining The Economist, she worked for Merrill Lynch in London, as London correspondent for FT Deutschland and an editorial-page writer at The Wall Street Journal Europe in Brussels. She speaks regularly on the BBC's World Business Report and television programs. Ms. Von Bredow has an M.A. from Columbia University.

He studied at the Plekhanov Institute of the National Economy in Moscow.

in public interest litigation and criminal defense cases. Mr. Yusoff is a Fellow at the Institute for Policy Research, Founding Director of GERAK (Movement for Democracy and Anti-Corruption) and a Founding Member of Malaysia America Friendship Alumni Association. He writes a weekly column for the daily Utusan Malaysia and has a law degree from International Islamic University Malaysia.

Mr. Žantovský has also served as Czech Ambassador in the USA and in Israel and as Spokesman and Political Director of the President's office for President Václav Havel. He is a founding member of the Civic Forum and of the Czech P.E.N. He has taught American Studies at Charles University and Euro-American Relations at New York University in Prague. Ambassador Žantovský studied Psychology at Charles University in Prague and at McGill University in Montreal, Canada.





## History of Selected Conference Venues

### **Žofín Palace**

Žofín Palace is situated in the very heart of Prague on Slovanský Island. Constructed in honor of Archduchess Sophie – the Princess of Bavaria and the mother of Emperor Franz Josef I of Austria – the original classical building was redesigned by Jindřich Fialka and rebuilt in the neo-Renaissance style between 1885 and 1887. In the 1930's, a garden, restaurant and a music pavilion were added to the palace. The island's shores offer beautiful views of Prague and Prague Castle.

## **Prague Crossroads**

Located in Prague's Old Town, the former Gothic Church of St. Anne was built as a Dominican Convent between 1319 and 1330 on the site of an old rotunda and a church. Closed during the reign of Joseph II, the church was deconsecrated in 1782, and its complex of buildings was turned into flats and a printing house that were in use until 1795. Established under the initiative of Václav Havel, the church today serves as a unique international spiritual and cultural center, the result of a joint venture of prominent architects and designers Adriena Šimotová, Bořek Šípek, Kurt Gebauer and Eva Jiřičná.

### **Goethe-Institut**

Located in Prague's New Town, the institute is situated in the beautiful Art Nouveau building of the former First Czech General Insurance Bank. Inspired by the architectural design of Jiří Stibral, the building was built in 1905 and decorated with bronze sculptures by Ladislav Šaloun. Used by the Embassy of the German Democratic Republic until 1989, the building today hosts the Czech office of the Goethe-Institut (since 1990).

## **Academy of Sciences**

Located on Národní třída opposite the New Stage and the National Theatre the main building of the Czech Academy of Sciences represents the neo-Renaissance architectonic style of the second half of the 19th century. It was built by Ignác Vojtěch Ullmann between the years 1857 and 1863 as the seat of Spořitelna česká (Czech Savings-Bank). In 1954 the building was transferred to the Czechoslovak Academy of Sciences. In 1992 the Academy was renamed Czech Academy of Sciences and kept the building as its main center of administration for the academy 's 54 public research institutions.

The Annual Forum 2000 Conference in Prague assembles global thought leaders and offers a voice to dissidents from non-democratic countries, facilitating the development of a worldwide network of those who support the core principles of Havel's legacy. Among the speakers at our annual conference are world-renowned personalities such as His Holiness the Dalai Lama, President Clinton, Madeleine Albright, Prince El Hassan bin Talal and numerous Nobel Laureates including Elie Wiesel, Shirin Ebadi and Joseph Stiglitz.

The conference is unique in being open to the public and attracts over 3,000 attendees and more than 3,000 online followers each year, mostly from the Czech Republic and Central Europe, but with an increasingly international audience. These include representatives from politics, civil society, media, diplomacy, academia and business.

## **Interfaith Dialogue**

The Interfaith Dialogue is an integral element of the annual conference and facilitates a unique dialogue between secular humanism and the world's spiritual traditions. Participants seek better understanding and deepening cooperation between world religions and political, scientific and economic leaders.
