WS 1: Police and the Investigation of Hate Crimes/Hate Violence (EN / RU individual translation)

The workshop will focus on the investigation of hate violence incidents. The discussion will cover the main problems of preliminary proceedings (proving of hate motive, second-class victims, discouragement of victims while reporting a "minor" hate incident). The attitude of the police towards an injured party and witnesses will be discussed (reluctance while investigating hate violence, perception of the victim as an inanimate tool of evidence, cultural incompetence while interviewing people from different backgrounds). The role of an advocate will be presented as well as some possible solutions (concept of the vulnerable victim).

WS 2: Roma in the Czech Republic (CZ / EN individual translation)

Czech Roma is the group most vulnerable to hate violence. The discussion will focus on the recent situation and position of the Roma community in the Czech Republic, with emphasis on the vicious circle of poverty, social exclusion and general hostility towards this largest Czech minority group. Long-term social exclusion and day-to-day discrimination will be addressed as possible sources and prerequisites of consequent hate violence. The generally hostile atmosphere against Roma may act as a justification for perpetrators.

WS 3: Lesbian, Gay, Bisexual, Transgender (LGBT) (EN / RU individual translation)

The Lesbian, Gay, Bisexual and Transgender Community is not recognized by the Czech Penal Code as a community at risk of hate violence. Any crime committed on the grounds of sexual identity or orientation bias is therefore investigated as a common crime, and any subsequent punishment will not take this motive into consideration. As an incident of hate violence often results in the victim coming out, the LGBT community faces a higher level of secondary victimization. Persistent homophobia and the prevalence of heterosexuality in society as well as the attitude of law enforcement and the fears and barriers of the victims of homophobic hate violence will be discussed. Experiences from different European countries will be compared.









WS 4: Anti-Semitism (EN)

Anti-Semitism is still present in European societies, although its visible manifestation is almost solely by right wing extremists. Holocaust denial still persists as a leading idea, and new forms of anti-Semitism relying on hatred against the new State of Israel also occur. Mr. Frankl will present the modern contextual face of this ancient problem with an example from the Czech Republic.

WS 5: Anti-Extremism and Hate Crime Legislation (CZ / EN / RU)
